

## Volunteering in America Study Released: Florida Ranks Low Among States in Volunteerism

The Corporation for National and Community Service recently released "Volunteering in America", a study of local, state and national trends in volunteering. The study shows that over 61.8 million Americans contributed 8 billion hours of volunteer service in 2008, almost one million more than 2007. Contrary to some predictions, the downturn in the economy has not negatively effected volunteering with 37% of programs reporting an increase in volunteers. Florida did not fare as well, ranking 49th among the states in the percentage of people who volunteer. Florida does slightly better in hours volunteered, ranking 44th. Compared to past years, Florida saw a small hike in volunteer rates and volunteer numbers in 2008, with roughly 300,000 more volunteers than 2007.

The majority of volunteers in Florida contribute their time to religious or educational organizations, accounting for 59.8% of volunteer work. Over the past 20 years, educational volunteer work has increased by 11.2%, while volunteer work with religious organizations decreased by 2%. Fundraising appears to be the number one activity for volunteers, both on a national and state level. This is closely followed by food collection and distribution. Tutoring, mentoring, and teaching are the three most popular volunteer activities for college students. About 26.6% of college students tutored or taught, while 23.8% mentored.

## Don't Let Your Students Get Duped by Online GED Scams

For today's 34 to 38 million adults in the US who never graduated from high school, passing the GED test is a key to both career and educational opportunities. That's because approximately 95 percent of employers and even more US colleges and universities accept the GED. Many websites offer fraudulent High School Diplomas and GED Credentials for exuberant prices, some exceeding \$300.

Don't let your students be taken in by such scams. Let them know that one must test at an Official GED Testing Center, typically located at local schools or community colleges. People are still spending hundreds of dollars on fast and easy programs that guarantee them a GED or high school diploma online. The reality is there is nothing fast or easy about the GED Exam. Developed by the GED Testing Service (GEDTS), it requires extensive preparation and it gauges comprehension of the standard high school curriculum.

It's important for adult literacy organizations and other education programs who aren't routinely exposed to GED Testing, to share information about scams with students interested in getting their GED. Here are a few facts to keep in mind:

• Any services that claim to offer a GED credential through any means other than an Official GED Testing Center is not affiliated with GEDSTS.

## Volunteering in America Study Released: Florida Ranks Low Among States in Volunteerism

The study identified several common issues that people often consider when deciding to volunteer:

- Fear of time commitment. Some people assume that if they volunteer, they will be expected to continue indefinitely. Be clear with potential volunteers about the time commitment and the process for discontinuing their service if needed.
- Community outreach and social networking. According to the study, people are more likely to volunteer if asked by a friend or family member. Encourage your volunteers to spread the word; they can be your best community ambassadors.
- Fear of not having the right skills to perform at an adequate level that is conducive to chosen organization. Be clear with your volunteers regarding the expectations, duties and the training provided for the position.
- A misconception that volunteers are usually retired individuals without children. According to this study, volunteers span a range of age, marital status, employment, and race. Thirty-one percent of volunteer work in Florida is performed by adults between the ages of 35 to 44. While the majority of volunteer service is conducted by adults, young adults are actively volunteering at an increasing rate.

Volunteer numbers across the country may increase again in 2010, due to President Obama's call to community service and the allocation of stimulus money to national service programs such as Americorps and VISTA. The Corporation for National and Community Service will commit \$29.4 million to support Florida's volunteer initiatives, which will give a much needed boost to volunteer numbers.

The study has a corresponding website (www.volunteeringinamerica.gov) with detailed regional, state and (large) city data. This site includes information on areas such as volunteer rates, activities, and volunteer retention. Users can even compare one city or state to another.

## The President's Volunteer Service Awards: A Great Way to Recognize and Thank Your Volunteers

The President's Volunteer Service Award (PVSA) is issued by the President's Council on Service and Civic Participation on behalf of the President of the United States to recognize the best in American spirit, and to encourage all Americans to improve their communities through volunteer service, and civic participation. PVSA acknowledges individuals, families, and groups that have reached a certain number of hours of service over a 12-month period or cumulative hours earned over the course of a lifetime. There are three levels of awards, as well as a President's Call to Service. The following are the eligibility requirements for each age group:

Three varieties of awards packages are available to individuals, family/group, and in bulk. Depending on which award package is ordered, award recipients can receive:

- An official President's Volunteer Service Award lapel pin
- A personalized certificate of achievement
- A congratulatory letter from the President of the United States
- A letter from the President's Council on Service and Civic Participation

Recognizing and honoring volunteers sets a standard for service, encourages a sustained commitment to civic participation, and inspires others to make service a central part of their lives. To date, the President's Council has partnered with more than 80 Leadership Organizations and more than 28,000 Certifying Organizations to bestow more than 1.5 million awards to the Nation's deserving volunteers. All awards must be ordered through an official "Certifying Organizations."

The Florida Literacy Coalition serves as a Certifying Organization and will work with you to verify hours and nominate volunteers for this recognition. Most schools and non-profit organizations can also apply to become certifying organizations. Registration is easy-just visit www.presidentalserivceawards.gov. This website also has many other helpful benefits, such as a record of Service, which is an online private log to keep track of volunteer hours, and a link to serve.org, which can provide help for finding volunteer opportunities.





The Florida Adult and Family Literacy Resource Center is proud to announce the launch of the Annual Adult Learner Writing Campaign. Students from throughout Florida are invited to submit original short stories, poems, or autobiographical narratives to be included in a published book that will debut at the 2010 Florida Literacy Conference.

The goal of this book is to allow adult learners the opportunity to build confidence while also improving their reading, writing, and critical thinking skills. 

- American Council on Education establishes GED guidelines, so avoid any solution or school that doesn't include all test areas or information about test areas.
- GED is a proctored test and is never available to be taken on-line. A list of Official GED Testing Centers can be found on the Florida Literacy Coalition website.
- The services offered by these sites are usually a questionable value, some exceeding \$300. The Official GED Exam is offered for a price that does not exceed \$70.
- Beware of fake accreditation and websites that offer diplomas based on life and work experience.
- Diplomas offered by these sites will often not be accepted by employers, colleges, universities or the military.

The efforts in creating awareness of GED scams have become great in recent years. Internet access has grown by 138% in the United States since 2000, and with that growth, comes the opportunity for such scams.

Giving people correct information about where they can get a GED is the best way educational programs throughout the state can reduce the amount of people being robbed of their money, and an opportunity to pursue an education. ## Florida Department of Education Establishes Adult Education Advisory Committees

The Division of Career and Adult Education (DCAE) recently restructured the adult education advisory system for the state of Florida. The purpose of the advisory system is to receive input and suggestions from administrators and practitioners throughout the state. The new structure consists of a cabinet and six standing committees. The cabinet provides a forum for engaging adult education practitioner leaders in discussions about new initiatives, critical trends, and state and national issues relating to adult education. The standing committees review and advise on programmatic issues that have been identified by DCAE, as well as the governing cabinet.

Members of the six standing committees were selected from a pool of nominations submitted by the state's adult education deans and directors. They are unpaid volunteers and will serve for two years. The cabinet members are the chairmen of the committees and representatives from several state organizations.

## **Tutor Tips**

#### **KNOW YOUR MEDICINE**

Purpose: To help learners read labels on medicine bottles and packages.

Preparation time: 20 minutes

Materials: Drug labels or photocopies of labels

#### **Procedure:**

- 1) Pre-teach and/or review vocabulary that students will need during the activity. You can use pictures or real items (medication bottles, packages, tablespoon/teaspoon, etc.). Help students become familiar with key words on each label. For example, if you want them to answer "how much," teach them to scan for the word "dosage."
- 2) Pair students and give each pair some labels and questions to answer together.
- 3) Switch pairs. One student has the label, and the other student asks questions about dosage, etc.

#### **IN OTHER WORDS...**

Purpose: To reduce the difficulty new vocabulary can create when listening.

Preparation time: 5-10 minutes

Materials: Listening material, paper and pencils or a whiteboard and markers

#### **Preparation:**

Go through the listening and pick some phrases that may give your learners difficulty. Try to think of ways to say those phrases in words that your students already know. Make two lists. The A list has the expressions as they are in the listening and the B list has your alternatives.

**Example:** For a listening in which people talk about jobs

<u>A list</u>	<u>B list</u>
Full-time	40 hours a week
Salary	рау
Part-time	up to 30 hours a week

#### **Procedure:**

- 1) Put the words/phrases from the first list on the board and elicit different ways of saying them.
- 2) Put the words/phrases from list B on the board in jumbled order.
- 3) Students match the words from list A and list B. Check answers.
- 4) Do the listening with tasks as you would normally do.

## Brenda Dann-Messier Confirmed as Assistant Secretary of Vocational and Adult Education



The U.S. Senate has confirmed Dr. Brenda Dann-Messier as the US Department of Education's new Assistant Secretary for Vocational and Adult Education. Dann-Messier has served for 10 years as president of Dorcas Place, a community based literacy organization in Providence R.I.

She also served on the R. I. Board of Governors for Higher Education and the board of the R. I. Higher Education Assistance Authority. Dann-Messier was

the Secretary of Education's New England Regional Representative during the Clinton administration. She holds a doctorate in educational leadership from Johnson & Wales University, and a master's degree in instructional technology from Rhode Island College.

## IRS Now Requiring Small Non-profits to File 990-N

In an effort to determine which of the 650,000 tax-exempt organizations are still in existence, the IRS is, for the first time, requiring all organizations with gross receipts under \$25,000 to file Form 990-N (E-postcard). The IRS has stated that organizations will lose their tax-exempt status if they fail to file for three consecutive years beginning in 2008. Organizations can file Form 990-N online at **epostcard.form990.org.** 

## Dropping Out of High School Proves Costly for Students and Taxpayers

Dropping out of school carries a heavy price for both students and taxpayers reports *The Consequences of Dropping Out of High School*, a new study from Northeastern University.

The study indicated that the joblessness rate during 2008 of 54 percent nationwide for young high school dropouts was 22 percentage points higher than that of high school graduates and 33 percent higher than those who had completed 1-3 years of postsecondary degree. The mean average income of dropouts (ages 16-24) was only \$8,358 year and young women who dropped out were nearly 9 times as likely to become single mothers as their counterparts with bachelor degrees.

The researchers estimated that the average cost to taxpayers, including incarceration costs, over the working life of each high school dropout at \$292,000.

# GED's 5th Edition Placed On Hold for GED 20/20

The General Education Development Testing Service (GEDTS) recently announced that it will not introduce GED 5th edition, which had been slated for January 2012. Officials plan instead to move from the current GED directly to what they identify as "a new comprehensive assessment program," GED 20/20. Some elements of GED 20/20 are expected to be introduced as early as 2010, GED officials say.
