

2004 Florida Literacy Award Winners

The following individuals, companies and organizations were recognized at the Florida State Literacy Awards Banquet for their outstanding contributions to literacy.

Outstanding Business Partner: Walt Disney World Company

For over 30 years Walt Disney World has provided leadership within education and literacy in the central Florida community. With one of the leading workplace literacy programs in Florida, Walt Disney World has worked to remove the barriers to learning that so often impact adults. By working with local literacy organizations such as the Adult Literacy League, issues related to time, cost and accessibility have been addressed by offering free, individualized, high quality instruction in the workplace. Hundreds of employees have improved their English language and literacy skills or earned their GED as a result of this initiative that serves as a model among Florida's workplace literacy programs.

Outstanding Literacy Volunteer: Judge Joseph Donahey

Judge Joseph Donahey's first foray into education was in 1974, when he helped establish First Step, a program supporting probationers seeking to pass the GED. Most of his current focus centers on a program that he started in Florida called "Judges in Schools for Children of Promise," a family literacy initiative. He has enlisted fellow judges to volunteer their time in this program that stresses the importance of education at a time when students are able to make positive changes in their school grades and attendance. Working with PAC Success Academies, this program provides educational opportunities and support services that open doors for parents to fully participate in their children's education. After being left blind due to an unsuccessful surgery, the Judge realized that he had become illiterate. He could no longer read unless he learned Braille. This experience combined with his efforts to learn Braille, enabled him to identify more deeply with the struggles each adult literacy student faces. Judge Donahey has touched many lives and continues to make a difference one school, one student, one family at a time.

Excellence in Education: Pinellas Public Library Cooperative, Deaf Literacy Center


This program is a library-based literacy program for deaf individuals and their families who need basic literacy skills, life skills training and general integration into the hearing world. It offers small group and individualized basic literacy instruction and support services in addition to traditional library and information services to the deaf. The Center also teaches American Sign Language and deaf culture classes to hearing children and adults in order to create a better understanding of the needs of this population and a deaf friendly library environment. Believing that the comprehension of printed and written information is necessary to function in society, to achieve goals, to develop knowledge, and to interact with the environment in which we live and function, the Center's services help their students and their families realize more productive, active and informed lives.

Flight for Freedom Award: Poommalee Marcenek

A recent immigrant from Thailand, Poommalee was recognized for making significant progress in English through the support of her tutor Marcia Geyer and classes she has taken at the Central Brevard Public Library. As her English skills increased so did her confidence and she was able to secure a job at Wustoff Hospital. She recently began going to school in Rockledge where she attends classes in computer literacy each weekday morning. Poommalee is truly committed to improving herself in the country she now calls home. Her tutor wrote, "I am proud to have gotten to know Malee and see the result of her dedication to becoming both fluent in English and also a working member of society."

Adult Learner's Book Review

This April, Read Together Florida, a project of the **Governor's Family Literacy** Initiative, encouraged people across the state to read Their Eyes Were Watching God, a novel by Zora Neale Hurston. The following excerpt is reprinted from Reader to Reader, Spring 2004, a publication of the Palm Beach County Library Adult Literacy Project. Adult learner Jerry Rivers wrote this book review after attending a discussion at the New Learners Book Club.

"This is the story of a poor black woman and tells of her life and the hard times she went through. Every sad time made her a stronger person. I think it's how real life is. You learn from your problems and mistakes, you learn how to make things better next time. I would not have picked this book to read; sometimes it was hard to understand. I think every book I read, I learn something new."

Mary J. Brogan Leadership Award: Harriet Little

A tireless advocate for adult literacy, Harriet began teaching for the ABE Department of Seminole Community College in 1978. Today she directs the department, manages 48 faculty and staff, and serves thousands of students. Her colleagues describe Harriet with phrases like "team builder," "a creative problem solver," "she empowers," "expects staff to use best practices," "innovative," and "deeply involved in community efforts to promote literacy." Among the innovative programs developed under Harriet's leadership are state of the art computer labs for ABE and GED instruction, the GED Academy, a GED Scholarship Program, and Probationers Educational Growth Grant. Harriet has contributed her time and counsel to many state and community organizations including the Seminole County Literacy Coalition and ACE of Florida. Literacy Ambassador Earns GED and Becomes Tutor and Advocate

Tuesday, May 11, 2004 was one of the happiest days of Monica Baxley's life. After 10 months in basic literacy and GED preparation classes at the Literacy Volunteers of Washington County (LVWC), she graduated from the Washington Holmes Technical Center. But she wasn't alone. Monica was joined by her husband and a fellow student, all donned in cap and gown. They received their diplomas together. After passing the GED last October, Monica began tutoring her fellow student in basic literacy and GED preparation earlier this

year. "It's wonderful to walk with my husband, but the reward that my first student is walking with me is the greatest!"

Monica first sought literacy assistance so she could help her teenage daughter, who was diagnosed with a learning disability, get through school. Reading at a fourth grade level upon entering the program, Monica struggled her whole life being able to understand and retain much of what she read. She excelled in her adult literacy studies and now is eager to share how the LVWC helped her.

"There's so much going on now! I'm so excited I feel like I'm gonna explode," she exclaimed with a huge grin and a bounce in her seat.

In recent weeks Monica's schedule has been packed with public speaking and literacy events. One week she attended a County Commissioner's Meeting where she told her compelling story and encouraged them to support local literacy efforts. Shortly afterwards she was featured in a local newspaper article. The following week she attended the Florida Literacy Conference and just before graduation she was interviewed by **Channel 7 in Panama City**. Shortly thereafter she spoke from a student's perspective to potential tutors at a basic tutor training workshop. "There's so much going on now! I'm so excited I feel like I'm gonna explode," she exclaimed with a huge grin and a bounce in her seat.

Monica was one of 19 participants who attended a two-day Literacy Ambassador training program sponsored by Florida's Adult and Family Literacy Resource Center. This initiative held April 2-3 in Orlando coached adult learners in how to effectively communicate their stories through public speaking and media interviews. It also provided administrators with information on how to promote their programs and create opportunities for their students to share their stories. Monica is one of many adult learners featured in a promotional video produced during the program. Monica expressed, "The workshop materials were wonderful. I often review them before each speaking engagement. I don't think I would have had the courage to speak in public without the training."

The Literacy Information aNd Communication System (LINCS) provides a comprehensive collection of family and adult basic skills research, teaching, learning and training resources. It can be accessed by going to www.floridaliteracy.org. Scroll to the bottom of the homepage and click on National LINCS.

One of the unique features of LINCS is the *Special Collections* that can be found at the top of the LINCS homepage. This grouping includes specialized information on high-quality literacy practices and materials for use in adult education and literacy programs in the following areas: Assessment, Correctional Education, English as a Second Language, Equipped for the Future, Family Literacy, Health & Literacy, Literacy & Learning Disabilities, Program Leadership and Improvement, Policy & Legislation, Science & Numeracy, Technology Training, and Workforce Education.

The *Health and Literacy Special Collection* is of particular importance since recent research by the **US Institute of Medicine** shows that about 90 million adults (half of the adult population in the US) have difficulty understanding and following health information causing serious consequences. This collection includes segments on current developments in health and literacy in "LINCS Newsflashes." It has a health related e-mail discussion group and can direct you to a wealth of information including teaching activities, curricula, websites and health brochures.

Each Special Collection is reviewed by a core knowledge group to guarantee the quality and timeliness of the resources. The site was developed in collaboration with the **National Institute for Literacy (NIFL)**, and its LINCS project.

Florida Well Represented Among Digitally-Savvy Community Colleges

The Center for Digital Education and The American Association of Community Colleges (AACC) have named the top-10 digital-savvy, cutting-edge community colleges in the second annual Digital Community Colleges Survey. The survey assesses how community colleges have progressed in using information technology to deliver services.

1,000 community college Presidents across the U.S. were asked to participate in the survey. Winners were grouped into three categories based on city and student population: large/urban, mid-sized/suburban and small/rural.

The Learning Disabilities (LD) Discussion List, one of 12 discussion lists set up by the National Institute for Literacy (NIFL), will now be moderated by Dr. Rochelle Kenyon, Master Trainer of Bridges to Practice. The LD Discussion List is an information exchange network for the sharing of information, research, expertise, and resources regarding the relationship between adult literacy and learning disabilities. Discussion topics have included causes and consequences of LD, legal issues related to serving adults with LD, classroom methods and materials, GED testing and accommodations, and training.

Members of the NIFL-LD list include literacy practitioners, administrators, and researchers, as well as others with a stake or interest in serving adults with learning disabilities.

U.S. Department of Education Launches Pilot Program on Reading Research

The Division of Adult Education and Literacy (DAEL) is launching a pilot program that will focus on implementing scientifically based research when teaching reading to intermediate-level adult learners. It will create a national dissemination system to help identify evidence-based practices and infuse them into state professional development. This system will facilitate program change and improve program performance by focusing on three levels of work: identifying evidence-based practices and innovations, translating research findings into teaching products and processes that teachers can use to improve instruction, and working with national and state professional development systems to embed those practices, products, and processes into teacher training programs and subsequently into instructional programs.

Study Shows How Brain Function Changes with Effective Reading Instruction

A brain imaging study, reported in the May 1, 2004 edition of **Biological Psychiatry** and funded by the **National Institute of Child Health and Human Development (NICHD)**, has shown that the brains of poor readers start to function like the brains of good readers after effective reading instruction. The findings indicate there is increased activity in a part of the brain that recognizes words. Director of the NICHD, Dr. Duane **Alexander**, says the images show that effective reading instruction not only improves reading ability, but actually

Tips for Reading Tutors

Be positive.

Praise goes a long way with learners who struggle in reading. Provide positive feedback when correct responses are made ("Great! The word is Sequoia.").

Be attentive.

Stop learners immediately after an error. Show them what to do and provide them an opportunity to do it correctly ("That word is 'trouble.' What word is this?"). Try not to use the word "no."

Be precise.

Provide clear and direct instructions ("Say this word" rather than "Would you say it?").

Be mindful of mistakes made during the session.

Record learner performance. Review anything that learners miss. Remember, learners "should say it like they know it."

Be diligent.

Work from the beginning to the end of the tutoring session.

The following Tutor Tip information has been provided by the **U.S. Department of Education.**

Be innovative.

Keep tutoring sessions lively and dynamic.

Be focused.

Try to ignore minor misbehavior. Only recognize good behavior.

Be patient.

Show learners that you care about them through your commitment and encouragement.

Be on time.

Arrive at least 15 minutes before the tutoring session begins. Make sure plans for the session and materials are ready so the session may begin as soon as the student arrives.

Be committed.

Once you have begun to tutor a student, remain with that student throughout the year.

Be results-oriented.

Gather learner performance data on a daily basis, and chart the data (using graphs, stars, etc.) to allow a visual display of improvements made in the program.
